# Our company

## How to go about it:

### Your 8 steps to success...

1. You register as a test customer at [www.tachocontrol-data.eu](http://www.tachocontrol-data.eu) and enter your contact details.
2. TachoControl DATA will activate your account and you will receive **free access** to the Telematics and TachoDownload portal for 5 days.
3. You can then contact us using our contact form or by phone to let us know that you would like to become a dealer.
4. If you are already a Semmler GmbH TachoControl test centre according to StVZO § 57b, you can register automatically using your personal login.
5. We will then provide you with direct access and a „Dealer Area“ will appear under „My Account“.
6. In the „Dealer Area“ under „Commission Settings“ you can then define the account to which your dealer commission should be paid out in the future. (This account may be different from your payment account.)
7. You can now start your own promotional campaigns – with your own affiliate links. Our system automatically recognises when a customer has selected your link and placed an order through it. This is how we ensure your dealer commission is credited to you.
8. If you are a workshop or a wholesaler, you have the option of providing our download devices from your inventory, so that when you make a sale, you can supply and install the devices directly to your customers. Of course, the customer can also purchase a device online and have it installed by us, including fees.

# What you should know...

**In addition to our general T&Cs, there are also dealer conditions that apply to you.** You can find these in your dealer area under „Dealer Terms and Conditions“.

After registering as a dealer on the TachoControl DATA website's dealer portal, the following separate contractual conditions apply in addition to the contractual conditions already found on the website:

1. TachoControl DATA is free to decide who will be accepted as a dealer after registration and will confirm the dealer's registration separately if necessary.
2. TachoControl DATA has the exclusive right of representation for the dealer's customers. This obligates the dealer to waive all rights to the customers named by him/her with respect to TachoControl DATA.
3. The dealer undertakes to ensure that his/her customer provides a link to the TachoControl DATA website. At the same time, the dealer will also provide a link to TachoControl DATA's website.
4. The dealer receives a one-time commission of 20% on goods ordered by the customer in the TachoControl DATA web shop, for customers identified to TachoControl DATA by name.
5. In addition, the dealer receives a commission of 20% on fees booked (not SIM or telephone fees) for customers registered in the TachoControl DATA web shop via the dealer's account, but for a maximum period of 12 months from the conclusion of the contract.
6. Payment of the dealer's accrued commissions will be made 14 days after payment of the invoices issued by TachoControl DATA to the customer. The payment is made from a commission amount of 20 euros, smaller amounts are collected up to 20 euros.
7. The commission is paid out to the amount specified by the dealer Bank account via SEPA transfer or to the credit card on file.
8. The dealer is not permitted to offer, sell or broker competing products. Should this be disregarded by the dealer, the dealer loses his/her dealer status including the right to receive commission payments, with immediate effect from the time the breach of the condition in section 1 becomes known.
9. The dealer has the right to add his/her company logo and address to the advertising brochures and to reproduce them.
